

Workers hold protest against privatisation of power divisions

Demonstrators burn an effigy of the Punjab government

THE TECHNICAL Services Union (TSU) Circle Mohali, Pensioners Association Circle Mohali, and CHB Workers staged a massive protest on Monday against the Punjab government's reported move to hand over the Kharan and Lalu power divisions to private entities. Demonstrators burnt an effigy of the Punjab government and raised slogans condemning the decision.

Union leaders Gurbaksh Singh, president of TSU Circle Mohali, Chief Advisor Lakha Singh, and Gurmeet Singh, President of the Powercom and Transco Contract Workers Union Circle Mohali, expressed concerns over the privatisation plans. They claimed that the process to transfer control of the Kharan and Lalu divisions into private hands is already underway.

Drawing parallels to the aftermath of Chandigarh Electricity Board's privatisation, the demon-

strators said that regular employees, pensioners, and outsourced staff there are now facing severe hardships. Past service records are reportedly being disregarded, with staff placed under one-year probation under arbitrary terms, they claimed.

The protestors vowed not to allow privatisation "under any circumstances" and pledged to use every means necessary to revoke the policy. They announced a massive convention to be held in Mohali on April 23, where future strategies and protest actions will be discussed.

Alongside the union leaders, many others participated in the demonstration, including Vijay Kumar (president, Pensioners Association), Gurmeet Singh (president, CHB Workers), Jatinder Singh (SDO, Pensioners Association Division President, Mohali), Zorawar Singh (president, CHB Contract Workers), Ekam Sidhu (Circle Secretary), and several other union leaders and workers.

The protestors vowed not to allow privatisation 'under any circumstances' and pledged to use every means necessary to revoke the policy. They announced a massive convention to be held in Mohali on April 23

regular, outsourced employees, and pensioners across Mohali to unite in opposition to the government's decision. They emphasised that the data from both divisions has already been submitted to the power corporation, following recommendations by the Punjab Development Commission (PDC), paving the way for privatisation.
