MP FLAGS WORKERS' PLIGHT IN LOK SABHA

MP Malleesh Babu raised the concerns of thousands of workers at Tata Electronics, which is involved in iPhone assembly at the Kolar Industrial Hub, at the Zero Hour of the Budget session in the Lok Sabha on Thursday. Babu pointed out that the company had hired 25,000 workers on a contract basis for three-year. However, with the completion of these contracts, the company has only regularised a few workers, while terminating thousands of others and replacing them with new recruits. He questioned the future of these workers and expressed concerns about how they have been unfairly treated.

Babu also raised the issue of whether Tata Electronics is adhering to labour laws and sought the intervention of the concerned minister to find an amicable solution that would prioritise the welfare of the workers.

Speaking to The New Indian Express, Babu emphasised that companies across the country, particularly in industrial hubs, must comply with labour laws. He criticised the practice of terminating workers without due consideration, stressing that these workers, who are skilled and hardworking, will be left without jobs.

The JDS MP assured that he would meet with the concerned union minister to address the issue of workers' rights. Additionally, he reiterated his commitment to ensuring job opportunities for local youths in Kolar, particularly during Disha meetings he chairs. He said terminating workers who have given their best is unacceptable, and vowed to stand against such practices.

Furthermore, Babu announced plans to call a meeting with senior representatives of private companies in the Kolar Industrial Hub to discuss workers' safety and ensure that their rights are protected.

Cash-strapped UoM presents ₹107 crore deficit budget

Projected revenue for current financial year stands at ₹295.59 crore, while estimated expenditure is ₹403.31 crore

THE University of Mysore, grappling with a severe financial crisis, has presented a deficit budget of ₹107 crore for the academic year 2025-26. The budget was tabled and approved during the Academic Council meeting held at Crawford Hall on Friday evening by finance officer K S Rekha.

The projected revenue for the current financial year stands at ₹295.59 crore, while the estimated expenditure is ₹403.31 crore, leading to a deficit of ₹107.72 crore. If the state government had released the full pension grant of ₹157.54 crore, the shortfall would have been only ₹18 lakh. However, with only ₹50 crore allocated, the deficit has widened significantly.

The expected revenue includes ₹177.68 crore sanctioned by the government for salaries and pension grants, comprising ₹127.68 crore for salary grants and ₹50 crore for pen-

sions. Additionally, ₹3 crore is anticipated as a development grant, and ₹4 crore for SC-ST student scholarships, bringing the total expected government revenue to ₹184.68 crore.

Internal revenue sources such as admissions, registration fees, coordination charges, and other fees are projected to generate ₹45 crore. Scheme B

courses are expected to contribute ₹3 crore, examination activities ₹50 crore, various assets ₹3.5 crore, and other sources ₹7 crore. This brings the total estimated internal revenue to ₹108.50 crore.

The university, now in its 109th year, has 1,822 pensioners, with the number expected to rise to 1,881 this year. A total

of 59 employees, including 21 teaching and 38 non-teaching staff, are set to retire. Consequently, ₹157.54 crore will be required for pension and pension-related benefits. The total estimated expenditure, including salaries, pensions, administrative costs, and other non-plan expenses, has been set at ₹403.31 crore.

Additionally, the university has earmarked ₹46.32 crore in revenue and ₹39.05 crore in expenses across 17 other accounts, including interest payments. However, these accounts do not contribute to the university's overall financial burden, as clarified by the finance officer.

The sports budget has been significantly reduced this year, with only a meagre allocation of ₹25 lakh, down from the previous ₹60-75 lakh. Scholarships for sports students have been slashed to ₹3,000 from ₹5,000.

The cost of chemicals used for swimming pool water purification has been slashed from

₹5 lakh to ₹3 lakh, which will suffice for only five to six months, according to physical education dean Dr C Venkatesh.

Vice-chancellor Lokanath expressed fears about financial difficulties starting from April, despite managing to cover pension expenses for March.

"With the rising number of pensioners, the financial burden has increased, and the pension fund is already depleted. He pointed out that while the government directly pays salaries for permanent faculty, the delay in recruitment has forced the university to pay guest lecturers, adding to the financial strain," he said.

In another directive, the vice-chancellor suggested that the Social Welfare Department take over the maintenance of university hostels, considering it a beneficial proposal. He instructed the director of student welfare to conduct a review and submit a report on the matter.

Sloth bear bites food laced with explosive, dies

Mysuru: An adult sloth bear got killed after biting an explosive laced food kept to hunt wild boars in Tellanuru village in Hanur taluk in Chamaraianagar district. The incident took place when the bear, in search of food, had strayed out of the forest area into the human habitat. The bear had accidentally bit the explosive wrapped with food which the miscreants had kept to kill wild boars in the village. The blast damaged the bear's jaw which was blown into pieces. The bear after struggling with pain succumbed to injuries. The villagers who came to know about the incident immediately informed the foresters. Cauvery wildlife ACF Mariswamy, RFO Sundar and staff rushed to the spot and took up investigation. The foresters who have registered a case are searching for the miscreants who had kept the explosives.
