On 3rd May 2011, troops of 94 and 133 Battalions of CRPF launched a joint operation against Maoists in the forest near the village of Hurhur, PS-Senha, district Lohardaga. As they advanced, Maoists lying in ambush triggered a series of IED blasts on the track, causing severe injuries to many personnel. Despite grave injuries, the brave troopers refused to surrender and held their ground, opening fire on the attackers. When some Maoists attempted to snatch their weapons, the resolute response of the injured jawans forced them to retreat. Unable to match the valour of the wounded troopers, the Maoists fled the area. Six gallant personnel - SI Pratap Singh, HC Satyabr Singh, HC Devanand Singh, HC D.C. Deka, Constable Gajender Singh, and Ct/Bugler Radha Kishan - later succumbed to their injuries and attained martyrdom. Their supreme sacrifice remains etched in CRPF's legacy. All the bravehearts were posthumously awarded the Police Medal for Gallantry.
