

CT/GD S. GOPAL DHEP DULHASTI 06-05-1993
CISF proudly remembers the supreme sacrifice of this brave-heart. On this day, he laid down his life at the altar of duty. His courage and bravery would remain an abiding source of inspiration for the force. The force will remain eternally indebted to him for his noblest deed.

CENTRAL RESERVE POLICE FORCE 6 May 1963
SI Rajender Singh of 4 Battalion of CRPF was assigned in Manipur for law and order duties. On 6 May 1963, he faced a life-threatening situation while on duty and made the supreme sacrifice. He displayed exemplary courage, presence of mind, and unwavering commitment in the face of grave adversity.

CENTRAL RESERVE POLICE FORCE 6 May 1989
Ct/Dvr Mohan Singh, attached to GC Bantalab, was assigned to drive a school bus. After completing his duty on 6 May 1989, he visited the Central Bank of India, Gandhinagar branch, to withdraw money. While waiting, he briefly took the seat of the Bank Guard. When armed militants attempted to storm the bank, he bravely resisted their entry, grappling with one armed intruder. Despite being outnumbered and eventually shot at close range, he held on until his last breath, preventing a major looting attempt. His gallant act led the attackers to flee. For his exceptional courage and supreme sacrifice, he was posthumously awarded the President's Police Medal for Gallantry.

While returning, the vehicle carrying SI Omnath and W/C Atma Prasad was hit by a powerful IED blast, followed by heavy Maoist fire. Despite severe injuries, both held their ground and returned fire, preventing the looting of their weapons. They later succumbed to their injuries, attaining martyrdom in the line of duty.
