- To approve the minutes of the last Annual General Meeting.
- To inform members about the status of the Society and its activities for the period from 1 April 2024 to 31 March 2025.
- To receive and consider the Annual Report and Statements of Accounts for the year ending 31 March 2025.
- To approve the Budget for the period from 1 April 2025 to 31 March 2026.
- To appoint the auditors of the Society and fix their remuneration until the conclusion of the next Annual General Meeting.
- To review and ratify revisions to the Members' Register during the year.
- To authorise the Managing Committee and the Chairman to take appropriate action to safeguard the property and interests of the Society.

The Managing Committee had invited tenders for repair work of the Vanka Mohalla building (property). The repair cost was estimated to be approximately ₹1 crore. Given the financial position/constraints of the Society and raising such huge funds for repairs seems is not feasible. Therefore, the only viable alternative is to sell the property before it depletes further and poses a safety risk and endangers life. The Committee recommends that members approve and authorise the sale of the property. Members have previously agreed with the Committee's assessment and approved the sale on multiple occasions.

A valuation report was obtained from registered actuaries and valuers. Considering the depleted condition and the facts that there are few tenants the property value was assessed the property at ₹1 crore for reasons detailed in their report. The Committee had also published advertisement for invitation of tender for the sale of the property in Free Press Journal and Lakshdeep newspapers on 06/07/2015, 04/08/2015, and 14/08/2015. The Committee wishes to inform building has since been demolished under BMC rulings in September 2024, leaving only the land parcel. Based on cost-benefit analysis, the Committee advises that the property be sold, as it is non-repairable, cannot be leased, and offers no other benefit. Members are hence requested to give the Managing Committee the following authority

- Approval for the sale of the property to be vested in the Managing Committee and the Chairman, to act as they deem appropriate.
 - Authorization for the Managing Committee and the Chairman to represent the Society in the sale process, including price negotiations.
 - Authorization to appoint lawyers, consultants, and valuers as deemed fit for the purpose.
